We will be beginning a Stanford educational Program called "Healthy Eating for Older Adults: beginning Mon. 4/11/16. The Healthy living Center of Excellence has provided books and educational materials for this program.

We are taking applications for the Commodity Supplemental Food Program at this time.

Guidelines for the program is as follows: less than \$1276/ month for single adult, less than \$ 1726/ month for a family of two. Must be over 60 years of age.

The COA was part of a Community Collaborative Mtg sponsored by the "Y".
