

**TAPED**

The License Commission held a Special meeting at 6:30 p.m. on Thursday, May 26, 2016 in Room B-9, City Hall. Present were Chairman Henry Tartaglia; Commissioners Joao DeAndrade and Harold Marrow; and Administrative Assistant Bonnie Tucker.

1. Request from Entertainment Management Complex, LLC – Todd Marlin, Manager, 1 Lexington Avenue, to amend the Entertainment license to include a Brazilian Concert and Rodeo at Campanelli Stadium on Saturday, May 28, 2016, from 4:00 p.m. to 11:45 p.m. with alcohol sales ending at 12:00 midnight. (At License Commission meeting on May 19, 2016 hours of Concert approved to 11:00 p.m.)

Present was Todd Marlin, 1 Feinberg Way, who stated they are requesting to amend the time which the Commission previously approved. The volume of the music will be turned down at 11:00 p.m. based on whatever Councillor Eaniri recommends. By 11:45 p.m., the music will end and alcohol sales will stop at midnight at which time everyone will be required to leave.

Commissioner DeAndrade asked what happened since the meeting to require the later operating time.

Mr. Marlin stated that there is one person who takes care of the rodeo side of the event and another individual promotes the concert. At some point they had contacted the Brockton Police Department to confirm that there is a license to 1:00 a.m. As a result of this information, they advertised that the show goes until 1:00 a.m. When he told them that the show had to end at 11 p.m., they flipped out and said they would cancel the show. They expect many of the attendees to arrive after 8:00 or 9:00 p.m. because many of their community work on Saturdays into the early evening and the early closing would have a severe impact on the attendance. At that point, Mr. Marlin stated he contacted Councillor Eaniri and explained the situation and asked him if he would have a problem allowing them the later time on this occasion.

Chairman Tartaglia stated he had spoken with Councillor Eaniri and he said he will go along with that. He cautioned Mr. Marlin to make sure the music isn't too loud.

Mr. Marlin stated that at the present time, they have sold about 1,300 tickets and they anticipate a good walk up crowd to bring attendance to approximately 3,000.

A motion was made by Commissioner Merian to approve the amendment which motion was seconded by Commissioner DeAndrade and made unanimous by vote of Chairman Tartaglia.

2. Any other business to properly come before the Commission.

A motion was made by Chairman Tartaglia to adjourn the meeting which motion was seconded by Commissioner DeAndrade. All members voting in the affirmative, the meeting was adjourned.
