BROCKTON LICENSE COMMISSION RULES AND REGULATIONS

All Alcoholic Package Stores Wine and Malt Package Stores

- 1. Any licensee intending to close his place of business for a period of more than forty-eight (48) hours must notify the Brockton License Commission in writing before such closing and he shall state in his closing the reason and length of such closing.
- 2. (a) No licensee shall contract bills for his licensed place under any corporate or trade name other than that under which he is licensed.
 - (b) Corporation managers in licensed places must not be changed until the License Commission has approved such change.
- 3. Assignment of stock in corporation licensed places for the purpose of safeguarding the assignee on loans, etc., gives no right to such assignee to conduct the business of the licensee; therefore, licensees must notify the License Commission immediately when the assignee forecloses under such assignment of stock.
- 4. (a) Licensee shall immediately notify the License Commission of any proceedings brought against them or any proceedings brought by themselves under the Bankruptcy Laws.
 - (b) Licensee shall immediately notify the License Commission of any court proceedings which may affect the status of this license.
- 5. All prices that can be seen by customers in your store whether on shelves, in circular form, or otherwise, must correspond with the current posted price list.
- 6. The licensed premises shall be subject to inspection by duly authorized agents of the Brockton License Commission and Brockton License Commissioners.
- 7. No alcoholic beverages shall be consumed on the premises except during a Wine or Malt Beverage Tasting held in accordance with the terms and conditions of Regulation #7A.
- 7A. A Wine or Malt Beverage Tasting may be conducted on the premises provided that the following terms and conditions are strictly adhered to:
 - (a) There shall be no charge or fee of any kind to a participant in a Wine or Malt Beverage Tasting.
 - (b) A Wine or Malt Beverage Tasting shall consist of a participant's sampling at one time of up to five varieties of wine or malt beverage available for sale on such premises.
 - (c) An individual serving of wine may not exceed one fluid ounce.
 - (d) An individual serving of malt beverage shall not exceed two ounces.

- (e) Each Wine or Malt Beverage Tasting shall be conducted under the supervision of either a representative of the wine or malt beverage wholesaler or distributor or an employee of the licensed premises designated by the manager for that purpose; if a licensee chooses to offer Wine or Malt Beverage Tastings under the supervision of a representative of the wine or malt beverage wholesaler or distributor only, he shall be responsible for any violation of this regulation to the same extent as he would be had he designated an employee to supervise.
- (f) The Wine or Malt Beverage Tasting shall take place in a designated area of the licensed premises and this area shall not be left unattended at any time during the period when Wine or Malt Beverage Tastings are being offered.
- (g) Individual servings of wine or malt beverages shall not be poured except during an individual Wine or Malt Beverage Tasting; any serving(s) not consumed during that time shall be promptly disposed of at the conclusion of that Wine or Malt Beverage Tasting.
- (h) The Wine or Malt Beverage Tastings shall be permitted only between the hours of 1:00 p.m. and 8:00 p.m.
- (i) All other statutes and regulations shall apply.
- 8. No licensee shall keep for sale, store or sell alcoholic beverages in any part of the premises not specified on this license.
- 9. No delivery of alcoholic beverages shall be made except during the legal hours of sale.
- 10. A current list of employees shall be available upon request of authorized agents of the License Commission and the License Commissioners.
- 11. All licenses and building certificates shall be posted in a conspicuous place on the premises, available at all times to the proper authorities.
- 12. Any police or agents complaints and/or reports, presently on file, <u>shall continue</u> in force until disposed of by this Commission.
- 13. No licensee shall make any distinction, discrimination or restriction on account of race, color, religious creed, national origin, sex or ancestry relative to the admission or treatment of any person.
- 14. The license is subject to suspension, revocation, or forfeiture for the breach of any of its conditions, or regulations of which the licensee has notice, or any law.

15. No advertising matter, screen, curtain, partition or other obstruction which in the opinion of the licensing authority prevents a clear view of the interior of the premise shall be maintained in or on any window or door thereof after said authorities have ordered the removal of such obstruction and having afforded the licensee thereof a reasonable opportunity to remove the same. The business conducted therein shall be open to public view from the sidewalk level and the establishment shall be properly lighted. No window or door facing a public way shall be obstructed by any screen or other object extending more than five feet above the level of the sidewalk on which the establishment abuts, but in no event shall any screen or obstruction prevent a clear view of the interior of said premises.
