The License Commission held a Special Meeting on Friday, February 1, 2019, at 3:00 p.m. in Room B-9, City Hall. Present were Chairman Henry Tartaglia, Commissioners Jeffrey Charnel and Paul Merian. Also present standing in for License Administrative Assistant Synthia Olivier.

1. Hearing for a Beer & Wine Permit from Ana Federico for an 85<sup>th</sup> Birthday Party at 891 Fruth Center Brockton, MA 02301 on February 2, 2019 from 7:30 p.m. to 12:00 a.m. expecting to have 100 guests.

Present was Cynthia Hodges of the Fruth Center representing on behalf of Ana Federico.

Ms. Hodges stated that Ms. Federico would be hosting an 85<sup>th</sup> birthday party at the Fruth Center for her grandmother. Ms. Federico thought no permit was needed and Ms. Hodges informed Ms. Federico that is incorrect and informed her that she needs a permit. Commissioner Merian asked if detail was needed. Chairman stated no police detail is needed for this event due to the amount of guests.

A motion was made by Commissioner Merian to approve the Wine & Malt Permit. The motion was seconded by Commissioner Charnel and made unanimous by vote of Chairman Tartaglia.

2. Hearing for a Beer & Wine Permit from Ulgma Oji for a Funeral Repass at 891 Fruth Center Brockton, MA 02301 on February 9, 2019 from 4:00 p.m. to 9:00 p.m. expecting to have 80 guests.

Present was Cynthia Hodges of the Fruth Center representing on behalf of Ulgma Oji.

Ms. Hodges stated this is what prompted the Special meeting due to this funeral repass. Normally Cynthia asks to have requests for Wine & Malt permits in to her in a timely manner, but funerals are unpredictable. No police detail is needed for this event.

A motion was made by Commissioner Merian to approve the Wine & Malt Permit. The motion was seconded by Commissioner Charnel and made unanimous by vote of Chairman Tartaglia.

3. Hearing for a Beer & Wine Permit for Nina Sousa for a Fundraiser at 891 Fruth Center Brockton, MA 02301 on March 30, 2019 from 6:00 p.m. to 11:00 p.m. expecting to have 60 guests.

Present was Cynthia Hodges of the Fruth Center representing on behalf of Nina Sousa.

Ms. Hodges stated the First Lutheran Church's Art Preschool is having a fundraiser. No police detail is needed.

A motion was made by Commissioner Merian to approve the Wine & Malt Permit. The motion was seconded by Commissioner Charnel and made unanimous by vote of Chairman Tartaglia.

4. Any other business to properly come before the Commission.

Chairman recommended to Cynthia that she apply for an annual Liquor license because you can only apply up to 30 permits per year. Chairman also stated Ms. Hodges is lucky that Commissioners Merian and Charnel were available to come in on such short notice and that may not always be the case. Cynthia stated that she is working with the Pastor to obtain an annual license. I, Synthia Olivier, have provided Cynthia Hodges with all paperwork including annual fees for an annual liquor license. Commissioner informed Cynthia to let the pastor know that she is not always guaranteed a special meeting and that she is only allowed 30 permit requests a month. Chairman stated that with a liquor license, you will have the option of both.

A motion was made by Commissioner Merian to adjourn the meeting. The motion was seconded by Commissioner Charnel and made unanimous by vote of Chairman Tartaglia.
