(On the situation with cars parked in violation in the snow emergency, necessary action was accomplished to assure that all residents of Brockton had safe and adequate Police and Fire and ambulance access; by citations, moving vehicles and tows. The entire Police Department, snow detail and both shifts 4-12 and 12-8 did an outstanding job that night.)

(Received many calls from residents regarding cars illegally parked during snow emergency. Called to speak with a Supervisor and did not get to speak to one.)

Comments by John Hallisey

(If it is safe to get a Fire truck/ Police car down a street then that would be a last priority. Would need to get some of the narrower streets first. Towing can take up to 30 minutes to get a car, we are not going to get everyone car out. We have increased by 400% since 2016.)

Comments by Councilor Beauregard

(Would like to get in front of it before hand so that people would be afraid to park because the tickets add up.)

Comments by Farwell

(Respectively, if we want to tow every illegally parked car, which takes time, we can be proactive in ticketing but if you want to try to tow every car that is parked illegally during a snowstorm then we better be prepared to spend a couple million dollars in overtime.)

Comments by Councilor Asack

(Who deals with the See Click Fix?)

Comments by John Hallisey

(Captain Porcaro handles them, if it is a shift problem he tries to do it right then, if it is time sensitive I would prefer for them to call the station. For snow emergencies call the station.)

Comments by Councilor Monahan

(Don't you also have the plow drivers call in when there is an issue?)

Comments by John Hallisey

(It is the Highway Foreman, we work together with them.)
