The Standing Committee on Finance met on *Monday, December 17th*, 2018 at 7:00 PM at the *Arnone School in the auditorium, 135 Belmont St.*, to consider the following:

1. ORDERED: That the City Council authorizes the acceptance and expenditure of the total grant funds in the amount of \$98,465 from the Community IT Grant. The City of Brockton in conjunction with the Brockton Public Schools District intends on expanding the capacity of the Public Safety Network, which is a dedicated fiber network to deliver all things related to Public Safety. Funding will be used to assist in providing needed upgrades in 10G fiber connectivity and better performance and stability of switching networks.
