Each order must be published at least 10 days prior to final passage and requires at least a two-thirds vote of all members of the Council. Councillor Sullivan motioned to move under suspension of the rules and act on item **#71** tonight and was properly seconded. He stated that the moratorium lapses in 3 days.

Councillor Farwell had no objections, but would like legal counsel to comment on this. There are 2 establishments so 2 stores should be able to go forward. The boards may need special meetings. Mr. Noble, whom Councillor Farwell doesn't know personally, besides maybe a hello, in legal fairness, the councillor feels Mr. Noble should be exempt.

Legal Counsel stated that it's pending zoning. Medical can still operate. They need to go to site plan review. Their location is grandfathered in.

Councillor Farwell stated that if at the February 11, 2019 meeting, if the report from Planning Board states lack of quorum, or postponed in Planning, we need to do something.

Councillor Eaniri stated that it has nothing to do with the Ordinance Committee. His concern is the locations in ward 3 in industrial area. They have received approximately \$275,000 in revenue. They could have received even more. Lets keep moving forward, as it is not fair to make them keep waiting.

Councillor Sullivan stated that the council got bashed by Mayor. He asked as chairman of the Ordinance Committee when the Planning Board are meeting and they are meeting on February 5. He believes it is because of the Mayor of Brockton and City Planner., because it could've been passed tonight if planning had their meeting. He believes that the council should vote on tonight.

Councillor Nicastro stated that they can't change the date of Planning Board to be any closer, so they should stay the course. They should plan on voting on February 11, 2019. She believes they should insist on special meeting if they don't have a Planning Board meeting.

Councillor Deroncourt stated that we have obligations. We shouldn't be on a waiting list waiting for Planning Board. Given that the council doesn't have the info, regardless, they can't have a Planning Board meeting any sooner. It is the Planning Board's responsibility to show up and do the job. Whenever they receive an appt., the council should keep that in mind that when we face an appointment, the appointee should be able to be at mtgs.

Councillor Rodrigues cautioned the councilors that they are voting for moratorium not everything to do with marijuana. We run risk of delaying it further. We would go forward without protecting us. We need to extend this.

He mentions the profoundly negative impacts the requests for funds will be to the city. In his opinion, we need to get a handle on what everything will cost. We have outstanding judgments and if others come forward with litigation against the city, he doesn’t know how we would pay for that. Remember it is being appealed, the meter is running. Maybe we should have a Resolve for the Chief Financial Officer to come before us. We are locking ourselves in financially. We do not want to be laying off city workers, because they have no funds. The implications of litigation, loan orders, and union agreements, cause him to see many red flags.

Councillor Beauregard stated that there is still time to do exemptions through the Assessors Office, which will be open at noon on January 31, 2019. There will also be a Ward Mtg. on Jan. 29, 2019 at 630pm. The topic will be Old Colony Planning Council regarding work on Thatcher, Pine and Summer St.
