These grant funds will be between the periods of July 1, 2019 through June 30, 2020 to continue to train first responders (police, fire and EMS) as well as other community members in the field of Mental Health First Aid; to host monthly Case Conferences/Citizen X community meetings; conduct follow-ups with mentally ill clients in the community; and process Section 12s and 35s through the District Court. The goal of this grant is to divert from arrest, when possible, individuals with mental health and/or behavior issues. The grant will hire at least one clinician to assist the department with follow up on families in the Brockton community and it will provide light refreshment at trainings in-state travel expenses. No match required.
