Ordered: That the common necessity and convenience of the inhabitants of the City of Brockton require the laying out and acceptance of **West Meadow Drive**, extending from Burroughs Road, northerly, to Julie Avenue, a distance of about 647 feet, more or less, and for that purpose it is necessary to take an easement for Highway Purposes and lay out as a public street or way of said City of Brockton.

(Deepest Sympathies to the City of Brockton.) (OPEP- Other Post Employee Benefits involves and entails the health insurance benefits for municipal employees. Multi employer trust set up for governmental entities to begin to fund their OPEB liability in a manner that saves them money has low fees and is going to produce over a period of time a greater rate of return than most of the other options. As of today we have 28 member units, we have more than 20 Million Dollars in assets under management and over the last three years we have had an annualized return of over 11%. No minimum contributions, no minimum timelines for requirement and no penalties.)

(As of our financial statements for June 30 2018 which is the last financial statements we have, our total accrued liabilities approximately 740Million Dollars.)

(First appropriation, something modest maybe a hundred thousand dollars; and then develop a long-term funding strategy for an annual amount that we would put in the trust.)

(Fairly aggressive. Designed a portfolio that we believe that will return between 6 and 8 % over the course of 30-40 years. Designed between 60-65 equities and the rest in fixed incomes and an investment professional at US Bank as well as a team of 1,000 members and an investment committee.)

(2) If payments from public funds have been made for charges formerly required of the corporation, such information shall be provided to the City Council. (3)Documents and information requested shall be provided within fourteen (14) days of the date of this Order.

(March 2015. Up to a year ago, anything over \$2,000 needed two signatures on a check; by board president and a board member. This was relaxed a year ago.)

(Were the accounts between the Shaw's Center and the Rox together?)

(In the initial year they were co-mingled but tracked by our accountants. Then I switched it in the subsequent year we opened separate accounts for the stadium and operations.)

(Can we agree that B21 was in a general description the landlord for the Shaw's Center and the Rox Stadium.)

(Yes.)

(How often did you send someone to go into the stadium or the Shaw's Center for the purpose of making sure that we were protecting the city's asset; that it was clean that we didn't have health code violations, missing property or damage, did that occur regularly?)

(Regularly. Minimally once a week, typically twice a week, and towards the end almost daily.)

(Who was going to check?)

(Many times me, but we had a number of service providers; plumbers, electricians and such and if they saw anything they would report it.)

(What was the board's requirement for routine inspections?)

(The board hired a gentleman who did an assessment of both buildings and that report was shared with the council in the past.)

(In regards to the Lease- On Page number one it's a representation of a document between B21 and EMC and it's believed to be true to be assigned original and not intended to provide a legal representation of a stadium agreement. What does that mean?)

(Because I cleaned it up; it didn't present itself well. It is the lease that we use as a reference because it is cleaner and neater.)

Weren't they supposed to keep it in good repair?)

Looking forward to find out what happened to that money with that refund.)

(I agree with you. The decision was made by the Mayor. There were to be a couple of events. There is no air conditioning there. It is not a usable facility. It costs the city more money than we are making. It took 77 man hours to get it ready for the last event.)
