FINANCE COMMITTEE MINUTES

The Standing Committee on Finance met on *Monday October* 7th, at 7:00 PM in the Council Chambers, Brockton City Hall, 45 School Street, to consider the following with President Sullivan presiding, eight members present, Councilor Asack, Councilor Derenoncourt and Councilor Monahan absent.

President Sullivan stated DPW Commissioner had a conflict, cannot make the meeting tonight. The CFO, Mr. Clarkson is on vacation this week. Councilor Monahan is unable to join us tonight.

1. Re-appointment of William R. May, Jr. of 61 Oak St., Brockton, MA to the position of Director of Planning and Economic Development for the City of Brockton for a five year term ending June 2024.

Comments by Rob May:

(Our office has done great job at bringing both the community and the planning organizations together. We have produced a city wide comprehensive plan for the first time in 20 years. We have worked in the Campello area on the east side and have plans to work in the Good Samaritan Medical Center area for life sciences and there is a new open space plan that we will be working on this year.)

(We have a metering power credit with Rehoboth and allows us 20% credit on electric bills. We own the meters but solar arrays are owned by the company. This is a bill we are requested to pay, we want people to know we are receiving a 20% discount on electricity through owning the meters from the power that is coming from the solar.)

(The project cost is \$331,590.00 and we are getting \$240,000.00 does this mean we have to make up the difference of \$91,590.00?)

(Stated she would need to look into that.)

Comments by President Sullivan:

(To Ms. Preval- do you think you would have an answer in a weeks time?) Comments by Karen Preval:

(Stated yes.)

(2) If payments from public funds have been made for charges formerly required of the corporation, such information shall be provided to the City Council. (3)Documents and information requested shall be provided within fourteen (14) days of the date of this Order.

(I agree with that. Should be addressed at the same time.)

Comments by Councilor Farwell:

(Don't need a home rule petition. We need to accept section 26 of chapter 111. Council only needs to accept section 26A.)

Comments by Councilor Cruise:

(There is a lot to this. There are two separate proposals. We can't do one without the other. There are other issues, would like to see the Mayor here. Would need an MD to become the director of the board of health. Need to examine the two pieces together; couldn't agree to do one without the other. We need the Mayor here and Dr. Brophy here to give us opinions on who is going to take that job.)

Comments by President Sullivan:

(Would like our legislative counsel here as well. Also review union to see what ramifications it may have.)

**On the motion- Councilor Cruise would like to have Dr. Brophy invited to the next meeting. Councilor Farwell would like to have Attorney Bridges and President Sullivan noted to have Attorney Shannon Resnick invited as well.

(Met with City Clerk Zeoli regarding this resolve; does the City Council acting as finance wish to move forward to the full council on a possible revocation of the licenses? If so, then we move favorable. The City Clerk has asked that we do it in November to give ample time for preparation and also proper notification. Either yes, we want to move forward and have a hearing at the full City Council or no we don't and it would be an unfavorable.)

(Do we have complaints from the police?)

(It is my understanding that we do.)

Comments by Councilor Eaniri:

(Is this the same garage that we did due diligence with last year?)

Comments by President Sullivan:

(I believe so. If we do go forward all the information and facts would come out during said public hearing.)

Comments by Councilor Eaniri

(Make sure the people that come before us also understand what we are doing. Would also be a great help because the people that came before did not, and if they need a translator to bring one; that was the issue we had a problem with.)

Having considered the same, Motion by Councilor Beauregard to report FAVORABLE back to the Full City Council, second City Council Meeting in November for the City Clerk to Authorize a Public Hearing, 2nd by Councilor Eaniri. Motion carried by a hand vote.
