The \$2,000 is for the Munis administrator to go out of state to a Munis show.)

Comments by Councilor Farwell:

(Not personal to Mr. Santos or the Mayor's administration. Transfer has brought interesting issues. Refers to the Ordinance section 2-327. States Mr. Santos' correct title is Assistant Data Processing Manager and is in the Union and did not want to take the Director's job. Refers to salaries of each position. Asking for overtime is inappropriate; having a department head in the Union scheduling himself for overtime and he is approving it. Would like the Council to know what is going on and should not happen in the city of Brockton.)

(States he will indeed look into this. Spoke to the CFO and will look into this and report back to you all. Mr. Santos has done an excellent job with his work and the city.)

(Noticed what we are amending was never signed or dated by the applicants and requested a copy of the fully executed contract. In order to make a decision before next week's meeting.)

(Decided to table this order, we all decided at the Mayor's suggestion that we split the \$200,000 and 50% will go to the Department of Economic Development and Planning to do some work in the transit village and Campello. The remaining \$100,000 will be held by the city in escrow anticipating some mitigation and to address issues that come up as the Thatcher Street project is developed. Which will be happening in the next 12-18 months.)

Comments by Councilor Nicastro:

(Tabeling this order which says \$200,000 to the Planning and Economic Development Department and resubmitting paperwork that reflects what was just discussed.)
