A Meeting of the Standing Committee of Real Estate was held on Wednesday October 28, 2020, in the Council Chambers, City Hall. The Committee Chairperson Councilor Lally called the meeting to order at 5:34 P.M. with Councilors Cruise, Nicastro, Mendes and Thompson present.





Meeting adjourned at 6:14 P.M.


