Current cases (as of 11/2/21-----): N=209, Cumulative cases (from the beginning to date): N=16,537, Deaths (due to COVID-19) N=448: Cumulative: N=16,515, Deaths: N=447; September: Cumulative: N=15,933; Deaths: N=444

V- Dashboard on COVID-19: the current statistics on the pandemic show Brockton in a more favorable position. In Brockton, currently our daily average of COVID-19 cases (as of 11/01/21) 21.1 per 100,000; the positive rate: 2.4%, Vaccination update (eligible population): 78.4% vaccinated, that is 64.9 % fully vaccinated, and 13.5% partially vaccinated.

VI- COVID-19 Vaccination continues to be a major component of the Board of Health day-today endeavors. In partnership with MDPH, BOH, the City of Brockton, and Brewster Ambulance, we officially opened a "Regional Booster COVID Vaccination Clinic" at the Shaw's Center on September 26. The current schedule is 5 days per week: Tuesdays & Wednesdays, from noon to 8:00 PM, Thursdays, Fridays and Saturdays, from 7:00 AM to 3:00 PM. First and second doses are also available for ALL three (3) vaccines: Pfizer, Moderna and J&J. BOH continues to vaccinate at the Cape Verdean Association (575 N. Montello St.) every Thursday, from 2:00 to 7:00 PM.

VII- PIH (Partners In Health) contract phasing out: the MDPH contract with PIH to help doing COVID-19 Contact Tracing is phasing out by November, which will create a gap in this important work. We have received a \$1 million grant (\$500,000/yr. for 2 years. We are actively interviewing applicants for 6 positions: 2 Epidemiologists, 3 Community Health Workers

(CHWs), plus 1 Administrative Assistant. We are diligently working to fill these positions this November.

Flu Vaccination: We have help 4 flu vaccination clinics in October: 2 at the COA, and 2 at City Hall for City Employees

VIII- BOH Van Project: The "Van is in operation. We use it 2-4 times a week for vaccination clinics

IX- BOH Nursing Vacancy: we are actively looking to hire one (1) RN to fill a vacant position.

X- Digitalizing BOH: We are a step closer to upgrading our Department so that, using current IT (Information Technology), it may become more efficient.

XI- New Name/New Face for BOH: As stated before, I was summoned to appear before the City Council to respond to inquiries on changing the Board of Health to "Health Department". Seemingly, the work is in progress, but I do not have the specific...

XII- A- Health Promotion & Public Health Education: MDPH has provided tremendous support throughout the pandemic. We continue to partner with various stakeholders around the City: community organization like Cape Verdean Organization, the School Department, Clergy groups, with different media outlets, Brockton Housing Authority, etc.
