An Ordinance Amending the Revised Ordinances of the City of Brockton, Chapter 2, Article III., Section 2-134. Holidays Be it ordained by the City Council of the City of Brockton That Chapter 2, Article III, Section 2-134 of the City of Brockton's City Ordinances be amended to include Juneteenth as a designated holiday.

SECTION 2-134. – Holidays is hereby amended as follows:

- (a) Designated holidays shall be New Year's Day, Martin Luther King Day, President's Day, Patriot's Day, Memorial Day, Juneteenth, the Fourth of July, the first Monday in September, Columbus Day, Veterans' Day, Thanksgiving Day and Christmas day.

This ordinance shall be effective upon passage.
