**MINUTES**

The Traffic held a Special meeting via Zoom, at 6:00 p.m. on Thursday, March 15, 2022.

Present were Traffic Commissioners: Traffic Commissioner Mark Porcaro, Deputy Fire Chief Joseph DePasquale, DPW Commissioner Pat Hill, Retired Fire Chief Kenneth Galligan, Councilor at Large Mendes, Councilor Asack, Director Stephen Hooke and Mr. Jim Sweeney.

There being a proper quorum, the meeting was called to order by Commissioner Porcaro at 6:02 p.m.

**NEW BUSINESS**

**1. AMC STUDIOS FILMING LOCATION/ REQUESTS (map attached)**

**Requested by: Peter Dooley, Assistant Location Manager**

**Issue/ Request: Requesting additional road closures and no parking areas for the week of April 21<sup>st</sup>**

Present was Peter Dooley and Jamie Merz.

Discussion: Map #1- March 21<sup>st</sup> are requesting No Parking on Bank Street and Ridge Street. There will be intermittent traffic control from 64 Bank up to Ridge. This will take place next Monday starting at 6:00am to 6:00pm.

Map #2 is location of trailers

Map #3- second half of Monday will be filming at Main Street at the Church first and then heading over to Cape Cod Café Pizza which will be staged as a jail cell. Cape Cod

will pose as a police station. There will be cameras and people in the road. This will be the last location of the day.

Deputy Fire Chief DePasquale addressed if anything was being done on Calmar because he was concerned for the Fire Truck station on Main Street. Mr. Dooley responded that they will have an emergency lane dedicated for vehicles. DPW Commissioner brought up that Calmar and Denton are 1 ways and Mr. Dooley and Mr. Merz stated that they will have detour signs. They will work with neighbors to get them through. They also stated that on Main St., Nason to Calmar will be shut down for ½ hour.

March 22, 2022 filming will take place on Myrtle Street where the crash scene will take place. They will need No Parking 300 ft. in each direction and will notify neighbors as thoroughly as possible. Road closures are to begin at 9/9:30am and looking to close some roads with police detail to redirect traffic. They will make sure neighbors are able to get to their homes. DPW Commissioner Hill brought up 3<sup>rd</sup> Street and Blaine Street because there would be less traffic in that area for possible crash stunt.

March 23, 2022 filming is back on Nason Street and pretty standard to the past.

March 24, 2022 filming will be taking place at the exterior of Beatrice's House located on Sycamore Street. They will be looking for intermittent traffic control and will be moving inside. They will be rerouting traffic for safety. They would like to shut down lights and will have police officers posted at lights. DPW Commissioner brought up the issues of the lights and shutting them down. Commissioner Hill stated that would not possible and if they could come up with something. Mr. Dooley and Mr. Merz stated their design team can come up with something to temporarily cover the lights and would only be about 6 lights to cover.

March 24, 2022 filming will take place at City Hall from 4:00pm to 3:00am. They will be utilizing Lot B and School Street. DPW Commissioner addressed areas of concern when filming around the City Hall grounds. The meters were also addressed and they would be coned off.

Councilor Asack to ask if there have been any issues or concerns that have come up during filming that the Council members were not aware of. Mr. Dooley stated that everything has gone smoothly with the exception of the school buses. There was a little bit of an issue in the beginning but after experiencing that, they were better prepared after and haven't had any issues.

Mr. Jim Sweeney asked if the slides could be shared with the public. Mr. Merz was not sure and asked if he could discuss that with his boss and get back to Captain Porcaro. Captain Porcaro stated even a scrub down version would be acceptable. Deputy DePasquale asked if there is was a contact person they could reach out to if there were

any issues. Mr. Merz responded that he would provide a contact info to the Board and he also has flyers with contact information to hand out to the neighbors for any issues that may arise.

Councilor Asack made a motion to accept and approve the plans presented, and the motion was seconded by Commissioner Hill.

Upon duly motion made by Councilor Asack, seconded by Commissioner Hill, the motion carried by a roll call vote; 8 in the affirmative.

**VOTED: TO APPROVE THE PLANS PRESENTED TO THE TRAFFIC COMMISSION BOARD MEMBERS.**

Motion was made by Councilor Asack, seconded by Mr. Sweeney to adjourn the meeting. All were in favor. Meeting adjourned at 6:43 p.m.
