The matters to be acted upon are:

5. City Council approval and adoption of the Fiscal Year 2023 Budget Order for Appropriations as presented or amended.
6. Ordered: That the City of Brockton appropriates the amount of Sixteen Million Dollars (\$16,000,000) to pay costs of designing, reconstructing and rehabilitating the City's sewer system, including, but not limited to cleaning, inspecting and relining sewer lines and mains, manhole rehabilitation, bypass pumping and all other costs incidental and related thereto. To meet this appropriation the City Treasurer, with the approval of the Mayor, is authorized to borrow said amount under G.L. c. 44, §8(4), or pursuant to any other enabling authority, and to issue bonds or notes of the City therefor. Further Ordered: That the City Treasurer is authorized to file an application with The Commonwealth of Massachusetts' Municipal Finance Oversight Board to qualify under G.L. c. 44A any and all bonds or notes of the City authorized by this vote, and to provide such information and execute such documents as the Municipal Finance Oversight Board of The Commonwealth of Massachusetts may require. 7. Ordered: That the City of Brockton appropriates the amount of Thirty-Four Million, Eight Hundred Thousand Dollars (\$34,800,000) to pay costs of designing, constructing, equipping and furnishing an advanced water reclamation facility (AWRF) necessary for the efficient disposal of biosolids, which project will include, but not be limited to, demolition of the existing incinerator, installation of new sludge thermal dryers, sludge conveyance equipment and all other ancillary systems and any

other related repairs and upgrades to the AWRP, and including the payment of all costs incidental and related thereto. To meet this appropriation the City Treasurer, with the approval of the Mayor, is authorized to borrow said amount under G.L. c. 44, §7(1), §8(14), or pursuant to any other enabling authority, and to issue bonds or notes of the City therefor. Further Ordered: That the City Treasurer is authorized to file an application with The Commonwealth of Massachusetts' Municipal Finance Oversight Board to qualify under G.L. c. 44A any and all bonds or notes of the City authorized by this vote, and to provide such information and execute such documents as the Municipal Finance Oversight Board of The Commonwealth of Massachusetts may require.
