**MINUTES – ORDINANCE COMMITTEE**  
**December 1, 2022**

The Standing Committee on Ordinances and Rules was called to order at 6:17 p.m. by Councilor Farwell, Mendes, Minichiello and Thompson present and Councilor Asack participating remotely for items 1 and 2.

Agenda read into the record.

Motion by Councilor Farwell to amend to add “The commission shall not investigate or adjudicate any complaint(s). However, the commission may refer any person to the appropriate agency responsible for reviewing matters involving alleged discrimination.” 2<sup>nd</sup> by Councilor Mendes.

(going over the issue the last couple of days, concern re opportunity to fix current board, Mayor just made recent appointments and reappointments, could be address by mayor, council has its own subcommittee on diversity and inclusion, wants to make recommendation that council subcommittee meet, HR, mayor, current committee, effort to fix current commission before it gets thrown out and replaced

Comments by Councilor Asack

(agrees with Councilor Thompson, before we re-write this ordinance, if we could take a look to have the committees come together with the Mayor’s office, let’s review it, talk to committees involved, see if there is another way before rewriting ordinance)

Comments by Councilor Minicheillo

(wants to see if current commission is repairable, doesn’t like the message, that this board is eliminated, wants to take a closer look to see if the board can be repaired, back door way of getting rid of the group, wants to hear from them, if needed, then would be in favor of this)

Comments by Councilor Mendes

(likes this the new commission, expands to a new level, good to hear from other members, at some point we need to expand on what the commission can do, does agree need to look at current board)

Comments by Councilor Minicheillo

(wants to hear from the commission to hear everyone's perspective, this ordinance is wonderful, can enhance the current commission)

Comments by Councilor Thompson

(subcommittee to specifically look at diversity, equity and inclusion of the council that can take time to look at this, make recommendations, some parts of the existing member would be eliminated, membership, let subcommittee and mayor weigh in, feedback)

Comments by Councilor Farwell

(does not disagree, filed out of frustration, minutes not filed, not problem soliciting the mayor, not looking for this to be turned into a circus, holdover members, looking to make new things a little better, no matter to refer to council to refer to subcommittee)

(employee, Brian Barker unable to attend, mission to save taxi industry in Brockton, only taxi company in the area, only one that works 24/7, tax cab is an important part of the infrastructure of the city, price increase, cannot believe the city council is in charge of this, only private industry that City is in charge of setting prices, meter set 3 prices, 1 is pickup charge, cost to send the vehicle, 2 is mileage, which is every 1/7 of a mile, 3 wait time, which is a lower rate, no change to wait time, last change was in 2008, UBER raises daily, at busy time it goes up)

(ineffective, calls come through dispatcher, to a specific address, danger has been minimized, cars have changed, mostly bucket seats now, drivers don't want to drive it, and customers don't want to use it, cab sitting in a parking lot doesn't make any money, wants to make it voluntary, high maintenance item, average call is \$10, which gets split between company and driver, need to deal in volume)

(not required for ride shares)
