 Ordered: That the common necessity and convenience of the inhabitants of the City of Brockton require the laying out and acceptance of **Deanna Road**, extending from Sinclair Road to Southfield Drive, and for that purpose it is necessary to take an easement for **Highway Purposes** and lay out as a public street or way of said City of Brockton, said easement passing by or over lands of those persons shown on "EXHIBIT A", attached hereto and parties unknown. Said layout of said street, being 50.00 feet in width, is shown more particularly on a plan entitled "**SOUTHFIELD**, SECTION I, BROCKTON, MASS., Developed by: Braintree Homes, Inc., Scale: 1' = 100', June 15, 1961 ", drawn by Bradford Saivetz & Associates, Inc., Consulting Civil Engineers, Quincy, Mass., recorded at Plymouth County Registry of Deeds as plan 91 of 1962 in Plan Book 12, Page 465, to which reference is hereby made for a more particular description.

8 Ordered: That the City Council dedicate the following percentage, which may not be less than twenty-five percent (25%), of the local option excise on retail marijuana sales revenues collected under M.G.L., Ch. 64N § 3 to the Community Impact Stabilization Fund established under M.G.L., CH. 40 § 5B effective for FY2024 beginning July 1, 2023, or take any other action relative thereto.

The following is yearly funded distribution generated from retail marijuana:

- Up to 25% of Total: to hire and retain public safety personnel
- Up to 20% of Total: for DPW infrastructure (i.e. Roads, Water and Sewer)
- Up to 15% of Total: to retain Teachers and Classroom support
- Up to 15% Total: for Youth programs and employment (summer jobs)
- Up to 10 of total: for Parks improvement and Recreational facilities
- Up to 10% of Total: for Social Services support (drug education and intervention)
- Up to 5% of total: for Senior Citizen support and the COA

If the percentage (%) of the totals in these line items are not used in a Fiscal Year, the remainder of the line item shall remain in the Stabilization account and added to the totals in the subsequent year.

Field Park Initiative and summarized results of the community survey recently conducted. They answered questions and responded to comments from the Council.
