- 1. Call to order 5:33
- 2. Meet and Greet--Janice Johnson Plumer discussed the Meet and Greet to be held on September 23, 2023, at the Brockton Public Library Lingos Auditorium. There is no fee to use the library. - A time-ordered agenda will be developed so that the event runs smoothly. For example, 10:00 – 10:20: refreshments & mingling, 10:25 – 11:00: Speaker, etc. Exact times to be developed.

- 4. Women's Commission email—Discussion was held about how to access the email account that has been issued to the Women's Commission. Also, discussion was held about changing the name on the website to City of Brockton Women's Commission, so all terms are consistent. Martha will contact Joe Johnson to discuss. Agreed that the officers would have access to the account.
