### An Ordinance Amending Article III, Division 2, Sec. 2-137. - Vacation Leave.

Be it ordained by the City Council of the City of Brockton as follows:

Article III, Section 2-137 – Vacation Leave is hereby amended by changing the title from "Vacation Leave" to "Vacation Leave and Personal Days."

And further,

Article III, Section 2-137 – Vacation Leave is hereby amended by replacing subsection (a) with the following:

(a) Every employee occupying a full-time position subject to the classification and pay plans shall be granted two (2) weeks' vacation with pay and four (4) personal days with pay after completion of ninety (90) days in a paid status. Thereafter, every employee shall receive two (2) weeks' vacation with pay and (4) personal days with pay annually, which shall be granted on the anniversary date of their original hire date. Any employee terminated within the first 90 days of employment shall receive no compensation for vacation leave or personal days granted under this ordinance.

And further,

Article III, Section 2-137 – Vacation Leave is hereby amended by adding the following subsection:

(k) Vacation Credit for Prior Experience. Notwithstanding the foregoing, the Mayor shall have the authority to credit an employee with all or part of the time that employee served in prior municipal employment, or in any other relevant prior employment as determined by the Mayor, when calculating the number of weeks of vacation leave granted by this ordinance. The authority granted by this section may be exercised annually or permanently and, in the case of employees under the

jurisdiction of the city council, by the city council, and in no event shall result in any employee receiving vacation leave in excess of the maximum amount of vacation leave granted by this ordinance.

And further,

Article III, Section 2-137 – Vacation Leave is hereby amended by adding the following subsection:

(l) Any personal days unused in the twelve (12) months after they were obtained will not accumulate. Personal days granted pursuant to this ordinance are intended solely as a benefit to promote employee wellness and work-life balance. These personal days shall not be considered wages, compensation, or remuneration for purposes of the Massachusetts Wage Act, as codified in Massachusetts General Laws Chapter 149, Section 148. Accordingly, employees shall not be entitled to payment for any unused personal days upon separation from employment or at any other time unless otherwise required by applicable state or federal law.

**947.**Resolve: WHEREAS: Heart disease is the number one cause of death in the United States and second leading cause of death in Massachusetts; and

WHEREAS: Heart disease, including coronary artery disease, heart failure, and arrhythmias,

significantly increases the risk of cardiac arrest, a condition in which the heart suddenly stops beating due to an electrical malfunction; and

WHEREAS: Cardiopulmonary resuscitation (CPR), together with an automated external defibrillator (AED), is the most effective way for bystanders to help someone in cardiac arrest. CPR keeps blood flowing to vital organs, while an AED can restart the heart by restoring its normal rhythm; and

WHEREAS: According to the American Heart Association (AHA), immediate CPR can double or triple a person's chances of survival after cardiac arrest, yet only about 40% of people who experience an out-of-hospital cardiac arrest receive the immediate help that they need before professional help arrives; and

WHEREAS: CPR classes can be taught in just 30 to 45 minutes, making them a quick and

accessible way to equip students with lifesaving skills; and

WHEREAS: 41 states have recognized the importance of CPR training by mandating it for

high school students, making Massachusetts one of only nine states that does not require it for high school graduation; and

WHEREAS: Massachusetts legislators have introduced five bills that seek to make CPR and

AED training a requirement in high schools across the commonwealth:

- S.447, An Act providing hands only CPR training and the use of defibrillators
- S.456, An Act requiring instruction in CPR and the use of defibrillators for high school graduation
- H.556, An Act providing CPR and AED Education for All, AKA The CPR and AED Education for All Act
- H.572, An Act relative to cardiopulmonary resuscitation and automatic defibrillator education in public schools;
- H.750, An Act providing hands only CPR training and the use of defibrillators now therefore be it

ORDERED: That this City Council go on record in support of S.447, S.456, H.556, H.572, and H.750 to ensure high school students receive CPR and AED training, equipping the next generation with life-saving skills; and be it further ordered

#### **ORDINANCE**

Be it Ordained by the City Council of the City of Brockton to adopt an Amendment to the Ordinance Prohibiting Camping of Public Property as follows:

Strike the language of Section 6 "Removal Process and Enforcement" in its entirety and insert in its place:

The Department of Inspectional Services, Parks Commission, Department of Public Works, Brockton Fire Department or their designees, and the Mayor's designee may be present at the time of removal in order to provide resource information, picking up sharps, and removing camping materials. The Mayor's designee shall be responsible for maintaining any data and/or records relating to resources and notice provided prior to any removal. The Department of Inspectional Services and the Mayor's designee shall coordinate the removal process. During any notice and/or removal, there shall always be at least two representatives/agents of the City of Brockton present.

The Brockton Police Department and/or the Department of Inspectional Services shall be responsible for enforcement of this Ordinance.

Insert the following definition to Section 2 "Definitions":

"48-Hour Notice" means the first written notice of violation of the ordinance as described in the Penalty for Violation section of this ordinance. The contents of the 48-Hour Notice shall include the date and time the campsite, any camping materials and personal belongings must be removed by, which shall be forty-eight (48) hours from the date and time of issuance of the notice.

Strike the following language in Section 8 "penalty for violations":

Any person who violates any of the provisions of this Ordinance following the 24-Hour Notice shall be subject to immediate removal and may be fined two hundred dollars (\$200.00) for the second and any subsequent offense. Each day the person is in violation of the ordinance shall constitute a separate offense.

Further, revise the first sentence of the first paragraph of Section 8 "penalty for violations" so that the language states, "Any person who violations any provision of this Ordinance shall be given a written warning for the first offense."

Further, revise the third paragraph of Section 8 "penalty for violations" so that the language states, "The City shall seek a criminal complaint for any subsequent violation of this ordinance"

Further, amend the ordinance so that any reference to 24-hour notice shall be amended to state 48-hour notice.
