RECAP OR "WHAT DID WE TALK ABOUT?"

We discussed...

- USDOT's Thriving Communities Program, and what the City of Brockton wants to accomplish through it.
- Work completed to date, including a site tour, pop-up engagement, and initial research about the community.
- The Community Engagement Toolkit.
- CAG Development and expectations

We learned...

- The City recently won a Safe Streets for All Pilot Grant, and the city plans to use the toolkit we develop to guide community engagement for that program.
- The public is generally disengaged and not encouraged to participate in ways that excite them.
- CAG members are excited by the opportunity to work directly with the City on this effort!

ARE YOU AWARE OF COMMUNITY ENGAGEMENT THE CITY HAS COMPLETED IN THE PAST?

- Most people don't know of city engagement events. "Didn't know about it!" is a common phrase.
- Some people are aware of events, but it doesn't always register that they are invited.
- Conference room meetings feel less accessible compared to community events out in the neighborhood.

WHAT IS THE BIGGEST BARRIER TO YOUR OR YOUR CONSTITUENTS/ORGANIZATION MEMBERS IN PARTICIPATING IN CITY ENGAGEMENT EVENTS?

- Engagement often feels "invite-only"
- Lack of Communication in other languages than English.
- Lack of "simple terms" makes conversations unapproachable to new audiences.
- Commitment requirement feels overwhelming, or the reward for participation isn't clear.

- the timeline for responses or implementation is too long. Participants want more instant feedback.
- It is not clearly communicated what impacts projects may have on different audiences.

WHAT ARE SOME NEW WAYS YOU WOULD LIKE TO SEE MORE ENGAGEMENT?

YOU ANSWERED...

- Sponsored ads on social media targeting different audiences.
- Send personal invitations where possible so people feel like their input is desired.
- Create "experiences," not just public meetings.
- Public Officials leverage their networks to promote engagement opportunities within their wards.
- Follow up with participants after every engagement

- Piggyback on other community events and share about the city projects.
- Create invites that can be shared through community organization newsletters.
- Hold events around themes or in tandem with other celebrations, such as Black History Month, Store Openings, etc.

HAVE YOU HEARD OF OTHER COMMUNITY ENGAGEMENT FROM OTHER COMMUNITIES THAT YOU WOULD LIKE TO SEE IN BROCKTON?

- Have games or competitions as part of engagement, such as scavenger hunts, volleyball, etc.
- When new stores open or new facilities, such as the Public Safety Campus, host tours and events that bring the community in.
- Food Pantry at Evers Park is a local and successful event.
- Back 2 School Bashes.
- More non-transactional engagements, like those in the non-profit sector.

- Pay for celebrities or local personalities to draw crowds.
- Host meetings in public spaces, such as Frederick Douglas Gardens, so they feel more accessible.
- Use ARPA Funds to fund park rehabilitation efforts and make it a community volunteer event.
- Brockton Area Food Network has a strong network and is a local success.
- Engage established businesses in Brockton, especially after COVID.

IS THERE ANYTHING ELSE YOU'D LIKE TO SHARE?

- the Frequency of the train is an issue during the middle of the day, keeping people from taking certain jobs across the region.
- The Department of Public Health measures public engagement through a Community Benefits Council.
- Internet access can be limited. Libraries are one resource for public internet access.
- Lots of people are disengaged from community development efforts because, while they live in Brockton, they feel like their neighborhood is elsewhere

- Safe Streets efforts needs more than physical infrastructure changes: policy support and systems changes are need for infrastructure changes to have the right effect.
- Education is needed to show bike lanes, for example, aren't an indulgence but critical transportation networks for those who bike.
- Generally, more education is needed on root causes of city issues and the impact infrastructure has on the city.
