OLD BUSINESS

1. WARREN AVENUE AT MARKET STREET

Requested by: Darcie Edwards

Request/Issue: The school year for Huntington School us being used again at 1121 Warren Avenue. I am the nurse at the school and there have been 10 car accidents since September at this intersection that require cars emergency service and cars being towed. Requesting that this intersection be a 4 way stop for the safety of the kids crossing the intersection. (Traffic Commission members please see previous CDM Smith engineering study)

SUBCOMMITTEE RECOMMENDATIONS:

A. Recommend implementing CDM Smith Engineering's short-term plan of making this intersection and all-way STOP and narrowing the Market Street approach from two lanes to one lane. This alternative approach will require newly-painted STOP bars and STOP stencils on Warren Avenue for pavement line painting season.

- B. Send a letter to the Building Department regarding the church sign in the southwest corner of the intersection that may be interfering with drivers' sight lines.
- C. Send a letter to the Mayor and Ward Councilor indicating this is being done *only as a short-term solution* until the city funds the engineer's primary recommendation of installing traffic signals.

2. 22 GRAND STREET

Requested by: Robert Cook

Request/Issue: Would like a handicap spot in front of his home. (handicap placard has been

provided)

SUBCOMMITTEE RECOMMENDATIONS:

- A. HP sign previously approved at June meeting.
- B. New sign to read HP PARKING HERE TO DRIVEWAY with corresponding arrow.
- C. DPW Traffic Division to coordinate with Mr. Cook and DigSafe for actual sign location.

3. 77 STERLING ROAD

Requested by: Ashley Donoghue

Request/Issue: Sterling Road is a cut through where people are heavily speeding in the morning and afternoon. Also, the members of City Center Gym are often speeding out of the parking lot and onto our street. Requesting Radar Speed signs, Advisory speed signs and/or regulatory speed limit signs.

SUBCOMMITTEE RECOMMENDATIONS:

- A. Lower the NO PARKING sign on Pole #4 on Beaumont Ave. for the westbound traffic.
- B. Cut back the vegetation and install a new NO PARKING sign with signpost on Beaumont Ave. near Sterling Rd. for the eastbound traffic.
- C. Cut back the vegetation around the SLOW sign on Beaumont Ave. at Sterling Rd. for the eastbound traffic.
- D. Install new SLOW signs on Sterling Rd. in the following locations:
 - Pole #8 (by 69 Sterling Rd.) for southbound traffic
 - Pole #4 (by 35 Sterling Rd.) for southbound traffic
 - SLOW sign with signpost in the area of 60 Sterling Rd. for northbound traffic.
- E. Traffic enforcement, when manpower permits.

5. 1154 WARREN AVENUE

Request/Issue: Would like the Traffic Commission to determine if a stop sign on Guild Road would increase safety and request a trimming of overgrowth limiting visibility.

SUBCOMMITTEE RECOMMENDATIONS:

- A. Install a new STOP sign, with signpost and red reflective striping to the southeast corner of this "T" intersection for the northbound traffic on Guild Rd.
- B. Paint a new STOP bar and STOP stencil for pavement line painting.
- C. Relocate the green GUILD RD street name sign from its current location to the top of the new Stop sign.
- D. Install a BLIND INTERSECTION AHEAD with the sideways "T" shape on Pole #5 by 47 Pinehurst Ave. for eastbound traffic.

Request/Issue: I am writing to express my serious concern about the traffic situation on Boylston Street, especially during the summer months. Our street has become increasingly dangerous due to a high volume of vehicles that divert from the nearby traffic light and speed through our neighborhood. This issue is especially concerning because many families on our street, including mine, have small children or walk in the area. The speeding and increased traffic pose a serious threat to their safety. We, as resident, urge the city to take immediate action to address this issue. Possible solutions could include: Installing speed bumps or raised crosswalks; increasing traffic enforcement or signage; adding a stop sign or traffic calming measures. We believe these changes are necessary to protect the well-being of our community and prevent potential accidents.
