Councilor's Recognition

Councilor Asack: She has scheduled an ordinance meeting for this Thursday, September 25th, at 5:00 p.m. here in council chambers.

Councilor Farwell: they routinely accept late files. He understands that the deadline for filing matters to be heard in council is noon on the Tuesday preceding their meeting. A citywide zoning issue, which was just referred to ordinance, or an amendment to that, or a zoning map, which is now to be included. He just doesn't think this is the way to conduct zoning business. And he's disappointed that they tend to make themselves look either ineffective or as if they're hiding something. They quickly take this late file in, then they quickly schedule an ordinance committee meeting for 5:00 on a Thursday, which makes it very difficult for anyone to get to that meeting if they work. He wasn't consulted it to see if he was available, and He is working. Fortunately, he believes he will be back in time for 5:00, but he just wants to make it known to all of his colleagues, how however unpopular this may be, they need to do a better job on substantive issues, getting them out to the public, letting the public understand what they're doing, letting the public read the documents that accompany what they're doing, and give them an opportunity to be heard. He knows there will be a public hearing on zoning changes after the ordinance committee meets, but that begs the question, why not go through the normal legislative process? Why not submit something by the noon deadline on the Tuesday preceding? A zoning map that was just read into the record tonight now has to be looked at by business organizations, residents. Does it affect them? Does it affect their neighborhood? He is for one just think they need to do a better job in how they handle these issues that comes before them because otherwise frankly if he was sitting out in the audience or he was sitting at home he would wonder well if they're doing something this fast what's the slight of hand here they know what's really going on and they know he can make a fool of himself very easily he doesn't need some legislative process that seems so abrupt and so quick to do it for him and he want them to do a better job. He's proud of the council, but the only way they're going to garner support in the public's eye is if they do things the right way.
