Quick recap

The meeting began with introductions and administrative matters, including a pledge of allegiance and roll call of committee members. The team reviewed the progress of their school feasibility study, which is currently in module 3 and involves assessments of existing conditions and building maintenance challenges. The group discussed upcoming educational visioning sessions and website development plans, while setting key milestones for the project's timeline through October 2026, with the next meetings scheduled for September and October.

Summary

Introducing Courtney to the Team

The meeting began with Kevin Sullivan introducing Courtney Henderson from the mayor's office to the SBC and the project team and turned the discussion over to Courtney to open the meeting.

Meeting Attendance and Minutes Review

The meeting began with the pledge of allegiance led by Courtney, followed by a roll call. A motion to approve the meeting minutes from the previous SBC meeting held on August 14, 2025, at 2:00 PM, was made and received unanimous approval.

Feasibility Study Progress Update

The team is currently in module 3 of the feasibility study, focusing on existing conditions assessment. KBA's consultants have been conducting field surveys and 3D scanning of the building, finding it to be well-maintained but at the end of its useful life, with some challenges posed by asbestos-containing materials. The team is preparing for educational visioning sessions in September, to be led by Craig Olsen and Kate Jessup of KBA, who will partner with Mike Pirollo of MLP Integrated Design, to develop an educational plan for the next 50 years. This will involve visiting recently constructed Massachusetts schools, consulting with educators, administrators and students, and creating a guiding document for the project's design and development.

School Project Planning and Updates

The meeting focused on updates and planning for a school project, with Kevin Sullivan providing an overview of the feasibility study process and key milestones, including an MSBA submission in December of the Preliminary Design Program (PDP) and a final submission of the Schematic Design in October 2026. Francois and Adele discussed the upcoming launch



of a dynamic, multilingual website to keep stakeholders informed, and Kevin encouraged committee members to review monthly reports and participate in upcoming meetings. The next school building committee meeting is scheduled for September 18, and a working group meeting will be held virtually on August 25 to continue discussions on educational visioning.
